## ANNUAL GENERAL MEETING TO BE HELD AT 5006 ANG MO KIO AVENUE 5, #05-01 TECHPLACE II, SINGAPORE 569873 ON 27 APRIL 2023 AT 10.30 A.M.

- 1. **Background.** Venture Corporation Limited ("Venture Corporation" or the "Company") refers to:
  - (a) the COVID-19 (Temporary Measures) Act 2020, which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to convene, hold or conduct general meetings;
  - (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020, which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies; and
  - (c) the joint statement by the Accounting and Corporate Regulatory Authority, Monetary Authority of Singapore and Singapore Exchange Regulation of 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020, 1 October 2020 and 4 February 2022), read together with the FAQs on "The Holding of General Meetings" dated 23 May 2022 issued by Singapore Exchange Regulation, which provides guidance on the conduct of general meetings amid the evolving COVID-19 situation.
- 2. **Date, time and conduct of Annual General Meeting ("AGM").** Venture Corporation is pleased to announce that its AGM will be held, in a wholly physical format, at 5006 Ang Mo Kio Avenue 5, #05-01 TECHplace II, Singapore 569873 on <a href="Thursday">Thursday</a>, 27 April 2023 at 10.30 a.m. (Singapore time). <a href="There will be no option for shareholders to participate virtually">There will be no option for shareholders to participate virtually</a>.
- 3. Question & Answer session with Chief Financial Officer and Group Finance Director ("Results Q&A") from 9.30 a.m. to 10.00 a.m.. The Results Q&A will be held before the AGM for shareholders to pose questions on the FY2022 Results of the Company at the same venue as the AGM. Registration for this session will begin at 9.00 a.m..
- 4. **COVID-19 safe management measures**. Venture Corporation may implement such COVID-19 safe management measures (including vaccination-differentiated safe management measures) at the Results Q&A and AGM as may be required or recommended under any regulations, directives, measures or guidelines that may be issued from time to time by any government or regulatory agency in light of the COVID-19 situation in Singapore. - 5. **Notice of AGM and Proxy Form**. The Notice of AGM and Proxy Form will be published on our corporate website and will also be made available on SGXNET<sup>1</sup>. For convenience, printed copies of the Notice of AGM and Proxy Form will be mailed to shareholders together with a copy of this announcement and the Request Form.
- 6. **Arrangements for participation in the AGM**. Shareholders (including CPFIS and SRS investors) may participate in the AGM by:
  - (a) attending the AGM in person;
  - (b) submitting questions to the Chairman of the Meeting in advance of, or at, the AGM; and/or
  - (c) voting at the AGM (i) themselves; or (ii) through their duly appointed proxy(ies)<sup>2</sup>.

In particular, CPFIS and SRS investors who hold Venture Corporation shares through CPF Agent Banks or SRS Operators and who wish to request their CPF Agent Banks or SRS Operators to appoint themselves or the Chairman of the Meeting as their proxy in respect of the Venture Corporation shares held by such CPF Agent Banks or SRS Operators on their behalf should approach their respective CPF Agent Banks or SRS Operators to submit their votes by **5.00 p.m. on 17 April 2023**.

- 7. **Persons who hold shares through relevant intermediaries**. Persons who hold Venture Corporation shares through relevant intermediaries (as defined in Section 181 of the Companies Act 1967 of Singapore), other than CPFIS/SRS investors, and who wish to participate in the AGM by:
  - (a) attending the AGM in person;
  - (b) submitting questions to the Chairman of the Meeting in advance of, or at, the AGM; and/or
  - (c) voting at the AGM (i) themselves; or (ii) by appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM,

should contact the relevant intermediary through which they hold such shares as soon as possible in order for the necessary arrangements to be made for their participation in the AGM.

- 8. **Annual Report 2022 and Letter to Shareholders**. The Annual Report 2022 and the Letter to Shareholders dated 5 April 2023 (in relation to the proposed renewal of the share purchase mandate) have been published on our corporate website and will also be available on SGXNET<sup>3</sup>. Printed copies of these documents will <u>not</u> be sent to shareholders unless specifically requested for via the Request Form that is mailed to shareholders together with a copy of this announcement.
- 9. **Record and payment dates for final dividend**. The Share Transfer Books and Register of Members of the Company will be closed from 5.00 p.m. on 9 May 2023 for the preparation of dividend warrants. Duly completed transfers in respect of ordinary shares of the Company together with all relevant documents of title received by the Company's Share Registrar, M & C Services Private Limited, at 112 Robinson Road #05-01 Singapore 068902 up to 5.00 p.m. on 9 May 2023 will be registered to determine shareholders' entitlements to the final dividend, subject to approval of shareholders to the final dividend at the AGM to be convened and held on 27 April 2023. Subject as aforesaid, shareholders whose securities accounts with The Central Depository (Pte) Limited are credited with ordinary shares of the Company as at 5.00 p.m. on 9 May 2023 will be entitled to the final dividend. The final dividend, if so approved by shareholders, will be paid on 23 May 2023.
