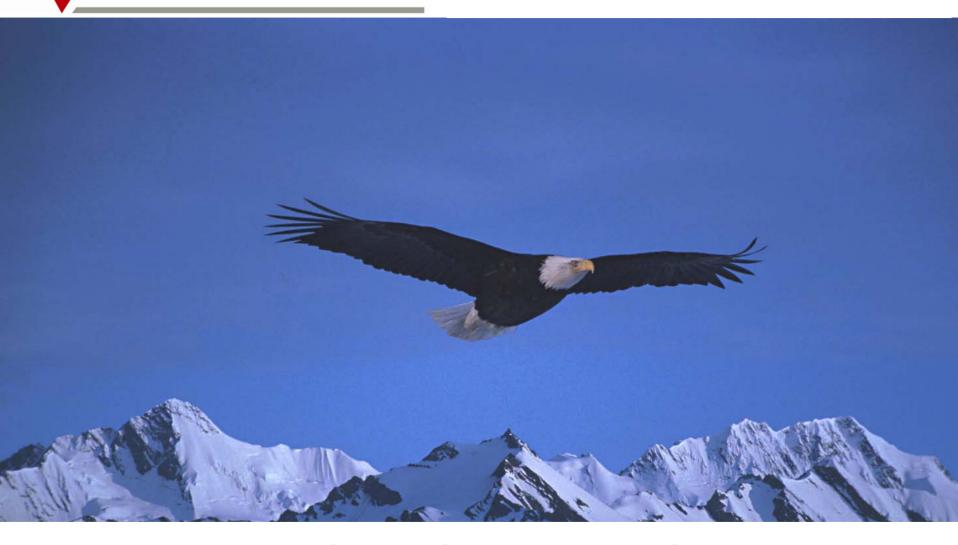

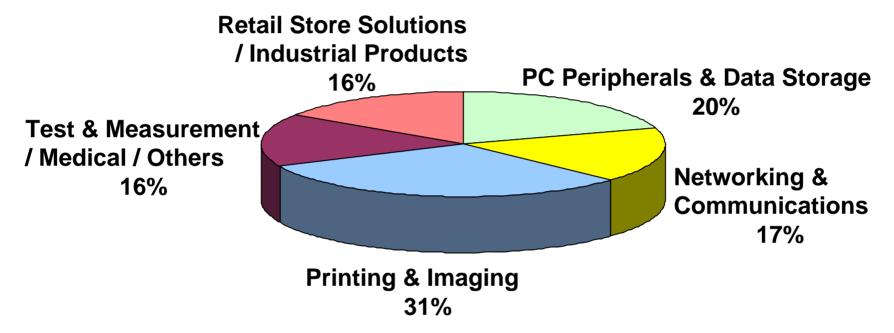

Q107 Revenue : S\$968.9 m

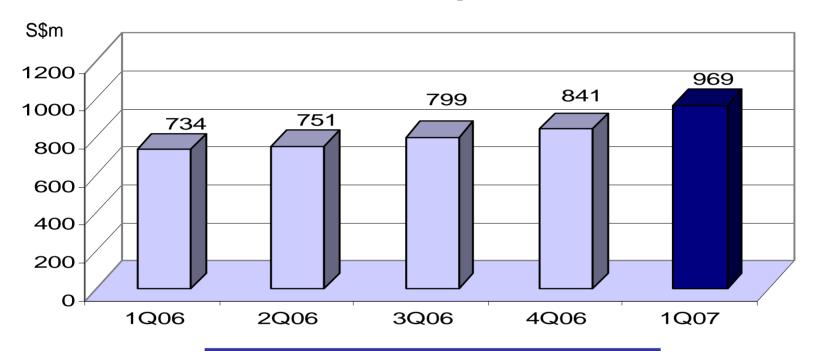

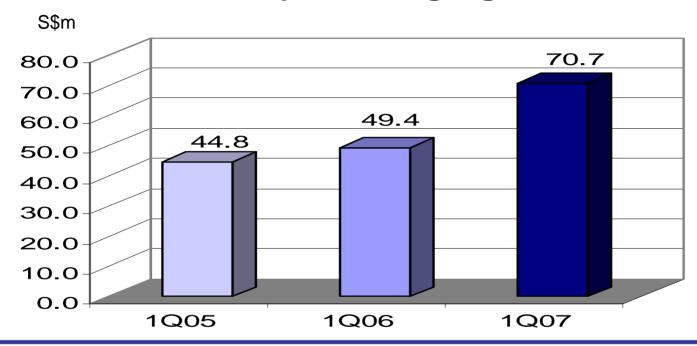

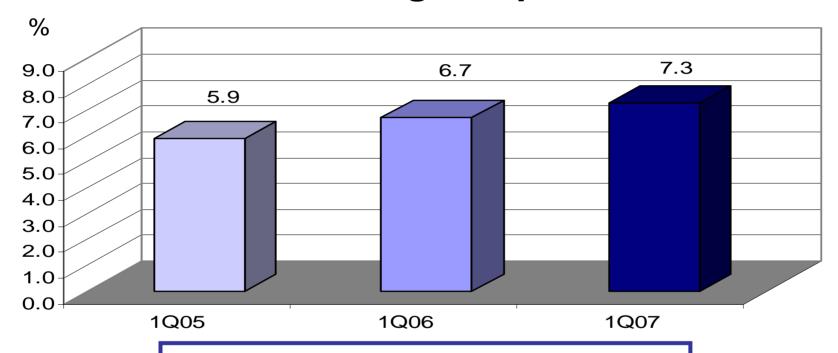
